We should be eternally grateful to those who, despite their pain, have brought to our attention what happened to them. Let's be thankful but not complacent that Tthere is now a much greater awareness in our society that such abuse of young people can happen. It is that recognition of the potential for abuse that has led to alterations to the statutory and regulatory structure in which establishments operate and how we monitor them. But simply changing the legal framework for protection is not enough.
