<p>i.</p>	<p>How many specific complaints of abuse of children cared for at the establishment have been made to the establishment/organisation?</p>	<p>We have provided the initial section 21 response and two addendum responses in relation to Quarriers Village.</p> <p>Following a further review of records we have now identified one further complaint which was made in a letter to an aftercare worker and was not included in either of the previous addendum responses. The letter was only recently found whilst looking through newspaper cuttings.</p>

iv.	Against whom was the complaint made?	QOB-QOC [REDACTED] (house parents)
v.	What was the nature of the complaint?	In a letter sent to a Quarriers aftercare worker, [REDACTED] the daughter of former Quarriers resident [REDACTED] stated that her family was aware that her father experienced "constant physical, emotional abuse and as we found out in his latter years probably sexual abuse" whilst at Quarriers. The letter also stated that the abuse became so bad that [REDACTED] would "hold his hand up in desperation hoping to be picked to go to Canada".
vi.	When/over what period was the abuse alleged to have taken place?	Not specified; at Quarriers between 1916 and 1924.
vii.	What was the organisation/establishment's process and approach in dealing with the complaint?	Unknown what response if any was provided to the letter.
viii.	What was the organisation/establishment's process and approach for investigating the complaint?	This matter was likely considered as a disclosure of abuse from many years previously and not a complaint. It was not investigated.
ix.	What was the outcome of the complaint following that investigation?	Not applicable.
x.	Did the organisation/establishment provide a specific response to the complaint?	We have not traced any response to the letter.
xi.	If so, what was the form of response e.g. apology, redress, pastoral response or any other type of response?	Unknown.
xii.	If there was no response, why not?	Unknown.
xiii.	Was the information/content of the complaint passed to police?	No.
xiv.	If not, why not?	This was likely on the basis that the events in question happened approximately 80 years previously.
